## Course description and content

The purpose with this course is to introduce and discuss theories and practices of qualitative methods in Human Geography and Social Science. It will provide both theoretical conceptualizations and hands on practical experience concerning the use and understanding of different qualitative methods and their implication for knowledge creation and advancement of research.

The course covers on the one hand a broad overview of methods to familiarize the participants with the variety and complexity of qualitative methods and on the other the course gives opportunities to reflect on and practice specific methods and discuss benefits and challenges of particular methodological choices. The course aims to include discussions of diverse theories and practices of qualitative methods including, but not limited to, queer methods, feminist methods and non-representational methods. Through the course the PhD-students will develop knowledge about the different steps in the research process; from selection of study field to a particular case; to selection of participants, conversations or visualization; through to collection of empirical material and finally coding interpretation, analysis and presentation.

The course will be organized through lectures and reading of literature followed by own assignments and workshops where different methods are discussed. The literature is a mix of classics in the field and new papers. Topics for the lectures and workshops will cover both different types of methods, such as different forms of interviewing, observing, and participating

as well as ways of analyzing text, visual material and discourses. General issues such as methodological choices, reflexivity, research ethics, embodiments and emotions in qualitative research will also be discussed. A special focus throughout the course will be the spatial dimensions of qualitative research, the researcher in the “field”, understanding the role of places and mobilities and developing context sensitive interpretations of empirical material. The examination will consist of active participation in the meetings and sessions and an individually written paper.

The course will take place during two separate meetings. In the course program, lectures will be mixed with seminar discussions, work-shops and paper sessions.

### **Learning outcomes**

After this course, participants will:

- have acquired in-depth knowledge of how the choice of qualitative research methods relates to scientific, philosophical and ethical grounds.
- get in-depth knowledge of a variety of qualitative methods and materials linked to analysing practices (e.g. discourse analysis, narrative analysis)
- be able to critically reflect upon central aspects of collecting, organising, analysing, and presenting qualitative data in relation to human geography.
- be well oriented in hands-on practice and application of qualitative methods.
- be able to discuss rigour, trustworthiness, credibility and validity in relation to qualitative research.

### *Sessions*

- Course paper step II: peer review of drafts. Before this second meeting, participants are asked to send in a draft of 1000 words. PhD students will discuss a first draft of their course paper and receive feedback from their peers.  
Submit 3 days in advance, read 4-5 other papers and comment.
- Lecture and research panel on analysis of data, transparency in qualitative research

- Lecture on how to practice data organising and analysis including power relations related to data management. This is followed by a panel discussion based on the course participants' questions.
- Visualisation and presentation of findings. Two researchers present their work including a discussion.
- Exercise: Practising geographical analysis: “Examining and (re)presenting the city” is a group exercise in which the participants are encouraged to experiment and use a combination of approaches to collect data and communicate their findings
- Working together seminar. What are the challenges involved when working together with researchers using quantitative methods?
